
#### **Dear Grandmothers and Friends**

We used it at our meeting in the park last week. An Afghan woman who just happened to be in the Park was attracted by the banner and came and spoke with us.

She was a refugee who had come to Australia in 2010. She is a nurse and worked in an NGO in Kabul. She married and now has a child. She spoke of the difficulties and mental illness of many Afghan refugees. She said she was Christian and her church in Dandenong was very supportive of many. She described how Afghans love picnics and those living in the cities go to country areas for picnics. We thought this may be something to do next year.

She quoted **an Afghan saying** '*When there is hope there is life*'.

#### Staying informed and connected

Our membership has been kept informed in 2021 by eleven newsletters and regular updates on our website. Five different flyers have been produced and distributed and up to 20,000 Morrison Government Report Cards are in circulation.

We have increased the G4R **social media presence**. We have an active Facebook page providing refugee news almost on a daily basis. Thousands of people have viewed and commented on the posts. We have posted comments and photos on Twitter throughout the year with some going viral to the extent of 30,000 views. We now have nearly 1,000 Twitter followers. We have established an Instagram account where we post telling photos of our activities. It has over 200 followers.

# AUSTRALIAN POLITICS HAS NEVER BEEN PERFECT BUT IT'S NEVER BEEN Worse than under The Morrison Government


Failures in trust, integrity, accountability, and honesty have all contributed to the cruel policy and inhuman treatment of refugees by successive Australian Governments over two decades.

### **Ending Indefinite and Arbitrary Immigration Detention Bill 2021**

On Thursday, 24 June 2021, the *Ending Indefinite and Arbitrary Immigration Detention Bill 2021* was referred to the Joint Standing Committee on Migration for inquiry and report. Grandmothers for Refugees will be making a submission to this Committee enquiry.


