

CALL TO ACTION 1

From your kitchen table... please write or call your local Federal MP and Senator to:

- Alert them to the 7-year anniversary of shame and your disappointment with the current 46th Parliament.
- Ask for details of the Government's plan to resolve the situation of refugees and asylum seekers not yet resettled.
- Ask for information on the health care being provided to men being held in the Mantra hotels in Preston (VIC) and Kangaroo Point (QLD).
- Ask your MP to forward a request to Home Affairs Minister Peter Dutton seeking an explanation for the continued detention of the children Kopika and Tharunicaa on Christmas Island and two-year-old Isabella and her mother Huyen in the MITA (Melbourne Immigration Transit Accommodation) centre.

Were you there? 19 July 2019


When 'social distancing' was not required behaviour?

Q1 Why is July 19 significant for people seeking asylum in Australia?

Q2 What was the background to this new policy?

Q3 What has changed since then?

Q4 What does the future hold?

Q5 Is there a better way?

A year later, and these questions remain relevant. For desperate people suffering another year of hopelessness, things are worse.

NO CHILD LEFT BEHIND CAMPAIGN - UPDATE from RCOA

Overview

There are currently around 16,000 children in families seeking protection in Australia. Many people seeking asylum have lost their jobs due to COVID-19, as they often work in the service sectors which are worst affected. People seeking asylum are not eligible for the JobSeeker or JobKeeper payments. **They have been left with nothing**. It will be hard for them to re-enter the workforce, especially in the current economy.

There are serious concerns that many families seeking asylum have been left in a situation where they have no work, no income, and no way out. Demand on emergency relief at asylum agencies has in most cases trebled, with unprecedented demand for food, medicines and rent relief.

We are building a coalition of educators, parents, carers and students who are working to put pressure on the Federal government to ensure adequate support is provided for people in this situation. The campaign is being led by educators including retired NSW principal Dorothy Hoddinott AO who had many children seeking asylum at her high school in Western Sydney.

To date, we have already secured powerful media stories, such as this piece in The Saturday Paper and this segment in Channel 9's The Today Show.

How to get involved

The campaign is going well, but we need your support! We are asking individuals and education-focused organisations to sign on. We have a joint statement for educators and a separate petition for the general public, both of which <u>can be accessed here.</u>

Here is what you can do to help the campaign:

- 1. Sign on to the joint statement or petition You can view and sign on to either the petition (for the general public) or joint statement (for educators) here. We are seeking signatories from individual educators, principals, parents and students as well as representative education bodies to a joint statement. For those not in education, the above link will direct you to a petition where members of the general public can support the campaign.
- 2. Share the statement and petition among your networks We have drafted this short article that you could use in any bulletins or newsletters you send out.
- 3. Connect us with educators, principals, parents or students you may know to speak to media about what they are seeing we are looking for any educators (retired or current) who might be interested in speaking to the media about what they are seeing at their schools with children seeking asylum, or just generally on the issue of the lack of support afforded to some families. We know that the way to build this campaign and achieve what we are trying to, is by having consistent media from educators. Email me with any contacts.
- 4. **Connect us with families seeking asylum –** If you know of any families seeking asylum who are in a tough situation as a result of Covid please get in touch. These direct experiences are the most powerful way to build the campaign. You can either <u>fill out this form</u> or email me directly.
- 5. **Help us organise the schools National Day of Solidarity –** On August 25 we are aiming to get 50 schools around the country involved in a day of solidarity with children and young people seeking asylum. The action will simple but powerful. Email me with any contact!
- 6. **Share content on social media –** We have put together a kit you can use to promote the campaign on social media, it includes Facebook posts, tweets, graphics and more.

INCREASING OUR IMPACT

We have been thinking of ways that we can work together to spread the message of our Four Demands more broadly.

We want to make sure that every MP in Victoria, at least, and their constituents hear our message!!

We are proposing that clusters of Victorian electorate groups collaborate so that where our numbers are small, support can be provided from neighbouring electorates.

Different groups would do this differently, but ideas might include Zoom meetings across electorates (Bendigo has reached out to Ballarat, for example), joint letter writing or telephone campaigns, letterboxing and, when we are freer, protests outside MPs' offices.

HEARING MORE VOICES

We are also suggesting that each cluster be invited to nominate one person to a new coordinating committee; we would like to hear more voices around the table (or via the Zoom screen).

SEND US YOUR EVENT PLANS

We would also like to be able to list upcoming events in your electorates. They might be regular or occasional vigils, meetings or letter writing sessions via ZOOM, or spatially distant walks with other refugee support groups.

We understand activities are limited now, especially in Melbourne metro area and Mitchell Shire.

If you let us know how you are continuing to advocate for our Four Demands, we will include it in the newsletter and on the website.

LATE NEWS - CALL TO ACTION



All people in Mantra and MITA should be tested for Covid-19, reassured of their status - so urgency in communicating results. If negative, release people into the community so as not at further risk (there is a 2 yr old and a man with cancer in MITA plus many others who are vulnerable).
