# Dear Grandmothers and Friends

The 21 May 2022 federal election delivered the change Grandmothers for Refugees sought for our nation.

After years of seeking to engage meaningfully with successive Coalition Governments, we judged a change of federal government would be better for refugees.

What we have now is a government with a better but not ideal refugee policy. In addition, on the parliamentary crossbenches we have independent minds and voices that are demonstrably inclined towards justice for refugees.

All of those members and friends who contributed time and funds and encouragement to this campaign for change can truly celebrate.



Yet the job for refugees is not done by any means.

In this special post-election edition, we pay tribute to everyone who has contributed to the change we needed to see for refugees.

While we celebrate the freedom granted to the Biloela family, we remain very aware of the thousands of others waiting in anticipation for their own freedom days yet to come. The new political context suggests we can look forward to our representations being more welcome, our conversations less defensive, and our letters and messaging being less pleading or combative.

Important to note is that the 'old' and new independent MPs and Senators are in WA, Qld, ACT, NSW, and Victoria.

To engage meaningfully with them, G4R needs strong voices in the communities they represent, beyond our traditional heartland of Victoria.

### How do we best go about organising ourselves to respond to the new political context?

The executive has already met to prepare for the Co-ordinating Committee meeting on 15 June at which we will begin our formal post-election review. All active electorates will be asked for a report on their local activities and this grassroots feedback will be the basis of our final report back to you and to our network of refugee support groups.

We will also plan for the election of the new team to lead our movement in responding to the necessary review of our strategic purpose in light of the new political climate.

We will keep you posted.

## Cruelty to refugees right to the very end

One of Scott Morrison's final acts as Prime Minister was to instruct the Australian Border Force (ABF) to publicise an interception of a suspected asylum seeker boat on election day.

As voters were going to the polls on Saturday, the Operation Sovereign Borders Commander issued a rare statement announcing a "vessel has been intercepted in a likely attempt to illegally enter Australia from Sri Lanka".

The ABC revealed that the highly controversial move during the election caretaker period followed a direct request from the Prime Minister's Office to publicly release details of the sensitive ABF operation before it had been completed.

The boat turn-back was confirmed by the incoming government which maintains support for Operation Sovereign Borders.

## Celebrating family joys for one and all

There is joy around the nation for the Murugappan family now living the dream promised by the new Labor Government.

They are going back to Bilo. Back to freedom, albeit under bridging visa conditions and unresolved court matters. Back to the lives they knew and the open arms of the people of Biloela who fought for them and would not forget them.

The campaign to bring home Priya, Nades, Kopika and Tharnicaa was waged through the courts of law and of public opinion. Stacked against them were the tens of millions in taxpayer dollars spent by the Morrison Government on court cases and the incarceration of the Sri Lankan family on remote Christmas Island. Following evacuation to treat a life-threatening emergency, the family has been living in Western Australia on conditional visas that prevented them leaving Perth. There is no available evidence to suggest that the treatment of the Murugappans was for any reason other than to build more political capital with far-right voters who the Liberal Party would rather vote for them than for Pauline Hanson.

This cruel way of doing politics was carried through to the dying hours of power by the Liberal Party when it sought to weaponize a small boat with presumably asylum-seeking passengers. This unseen boatload, allegedly sailed towards Australia from Sri Lanka, was framed as a real and present - even audacious - threat to the very security of our nation, on the very day of our triennial democratic voting ritual, no less!

This suspiciously convenient announcement may yet be the subject of a public integrity investigation into the use of Border Force resources by a government in caretaker mode.

Ultimately, for Nades, Priya and their girls, it was a rising tide of media interest, growing community awareness and visceral incredulity at the cruelty inflicted by the Morrison government on this little family that cut through.

# Happiness for the Murugappan family is shared by refugee families, despite the knowledge that the joy of freedom is not theirs to share. Herein lies a dilemma.

Surely, the cause for joy created for one ought to be applied to all in similarly compelling circumstances. Will other refugee families now be freed too?

This is an important question coming so soon after Prime Minister Anthony Albanese said respect and kindness would characterise his government. For that to be realised, those values need to be constant in their application. A lack of constancy would raise reasonable questions about partiality for the loudest voices.

No less worthy but less visible than the Biloela family are the many refugee families silenced by fear of repercussions if they speak out. They include adults who have been not only threatened with harm causing them to flee for their lives but those who have survived the traumatising pain of inhumane torture. Their claims have been put to the test and most have been recognised as refugees.

These families include children, some who made the perilous boat journey and others who were born, like the Biloela girls, right here under the Southern Cross. They have been daily witnesses to the tragedy of their parents' inability to provide for them and give them a safe future. They remain in community detention or under the cloud of six-month visas that limit their scope to work, study and hope. They live precariously, surviving on charity and the kindness of strangers.

# The traumatic stories of people fleeing for their lives should not have to be splashed across the pages of our newspapers or social media platforms in order for them to get compassionate and just treatment from our national government.

This is not an argument against freeing the Biloela family. Quite the opposite. It is the right thing to do. This is about making sure it is for the right reason. If so, others will be freed too.

There are Australian communities well practised in welcoming and supporting refugee families. Like the people of Biloela, these communities are ready to welcome refugees as permanent residents and neighbours who, like the rest of us, are looking for the better future we have been promised.
